With EMAA I under our belts, the board has been busy analyzing the effectiveness of the 2018 changes. Aside from a few hiccups, the main goal of time management was achieved. It was nice to sit and talk with fellow EMAA members and have a good night's sleep. Overall, I think all the countless hours on the show bill really paid off. I would like to thank the membership for all the support and patience at the first show as we worked out the kinks.

For MSU the main ring will be split on Saturday morning with halter on the North end and showmanship on the South end. If you are in a class and your other class is going in soon please let the gate person know. WE WILL WAIT FOR YOU!! It is very important to us that you make both classes and will do everything we can although if we are not aware we cannot help. We are anticipating both halter and showmanship to end approximately the same time as it did at the first show. There will be an hour break after all in hand classes are completed Saturday in the main ring. The main ring will be open that hour for warm up. Please note that ring changes may occur pending weather, listen for announcements.

About 30 mins after showmanship and halter classes are complete we will begin English/Western riding in the North end make-up ring. This class should be done about the time that the Main ring hour break is complete and warm up will then be moved to the usual north end ring.

Trail will be set up in the far north ring across the parking lot and open for 2 hrs for participants after English/Western riding is complete. Please note that no one has permission to enter the trail course prior to the class except when the trail coordinator allows an on foot review. Anyone going through trail obstacles to practice prior to the class will be disqualified and all year end points for that class will be eliminated.

Pending time constraints, Liberty will start approximately one hour after the last class. There is currently a waiting list for Liberty. If you would like to be on the list please email dowrebec@gmail.com.

- vi. We may start offering refunds for ribbons turned in.
- vii. We may run 50/50's at each show.
- viii. As for the banquet, we will have a budget defined and we may only allow discounted meal tickets to members; all others would have to pay the price of the meal.
- ix. The Chase fee should be reduced this year but we are still looking at other options for Chase Merchant Services.
